

### Act Now, Don't Delay: PFOA Is Toxic

Perfluorooctanoic acid is the full name of PFOA. It has entered into the city's drinking water supply through a process known as leaching.

PFOA contamination also appears to have occurred in private wells around the area. To be safe, don't drink the water. Don't cook with it.

The American Cancer Society has studied PFOA. It has found evidence tying PFOA to a number of different cancers. These include liver, pancreas, testicle and mammary gland cancer.

PFOA cancer or a PFOA disease can develop from a surprisingly small exposure to the toxic chemical — all that may be necessary in some instances is contact with as little as 0.5 parts per billion of it. Here are the main health consequences of PFOA exposure:

- Osteoporosis
- Loss in bone density
- Testicular cancer
- Pregnancy-induced hypertension
- Kidney cancer
- Thyroid disease
- Ulcerative colitis
- High cholesterol

These are the kinds of harms that should entitle you to be compensated by the companies responsible.

#### PFOA Contamination Puts Your Family in Danger

PFOA contamination in North Bennington, Vermont, is real. The evidence of the danger it represents grows with each new test conducted by the state.

The Vermont Department of Environmental Conservation (DEC) recently reported that PFOA levels it found in the water supplies were as high as 2,270 parts per trillion. To put that in perspective, the Vermont Department of Health places the safe limit of PFOA in drinking water at just 20 parts per trillion, according to Vermont Public Radio.

After it is discovered that a city's water supply is laced with PFOA, health and environmental officials typically recommend that residents immediately switch to using bottled water for cooking and drinking.

The PFOA contamination is the worst for North Bennington homes nearest the site of a factory where PFOAs were used to make water-repellent products. The Chemfab factory was shut down in 2002.

The company that owns Chemfab is Saint-Gobain. Erin Brockovich and Weitz & Luxenberg, P.C. are already taking Saint-Gobain to court over another PFOA water contamination crisis. Just like in North Bennington, residents of Hoosick Falls, New York were drinking PFOA-contaminated water without realizing it.

You are not responsible for the harm being done to you. But some company is. Holding that company — or companies — accountable is the fair thing to do.
